8- Technical Directors Report – Doug (VE3HTR):

The Club operates 8 repeaters and one APRS node.

The VE3SDG VHF repeater, 145.570 (-) is experiencing poor performance .

It is expected that the dual band antenna is causing the problem. The site will be visited on Friday October 27, 2023 to investigate.

This antenna was scheduled to be replaced in the spring 2024. It may need to be replaced immediately. An expenditure of \$300 to replace the antenna was requested by Doug.

Motion to approve expenditure of \$300: Doug (VE3HTR) Seconded by Roger B. (VA3GBV) Adopted unanimously.

The AIS receiver went offline several days ago and was brought back to Doug's QTH for repair. The cause of the failure was the Raspberry-Pi which was replaced.

The unit is temporarily online from Doug's QTH and will be reinstalled at the CCH site on Friday October 27, 2023.

Earle (VE3IMP) and Doug (VE3HTR) stressed the importance of the internet for Amateur Radio providing world-wide coverage from local repeaters using several technologies:

- All Star network
- DMR using Brandmeister network
- Wire-X using Yeasu Fusion
- AIS (Automatic Identification System) position reporting
- APRS position reporting

Motion to approve Technical Director's report: Jason (VE3PRY) Seconded by Dean. (VA3BS) Adopted unanimously.

9- On-going business:

- a. <u>Club Banner</u>: Dan (VA3SDO) brought the 2 banners he had prepared for the SVARC at no cost. One of the banners was put on display during the meeting for members to see. Many thanks for Dan for providing these banners.
- b. <u>Fox Hunt</u>: The last hunt was held on Sunday, October 15, 2023 and hosted by Steve (VE3EZB). The winner of the hunt was (appropriately) Hunter (VA3HWF). Hunter will be the host of the next Fox Hunt to be held on November 5, 2023.

10- Bylaws amendments:

The present section 6.3 of the By-Laws reads:

The Executive has primary responsibility for managing finances. Routine operating expenses are handled by the Treasurer, who reports these at each Member's meeting. The Treasurer is authorized to spend up to \$200 on normal operations items without prior approval by the Membership. Any significant, non-routine payments, within this limit, must be agreed to, at minimum, by the President and the Treasurer plus 2 others of the Executive. This will be reported upon at the next Members' meeting.

There is no mention as to how to process expenditures over \$200, so it is proposed to add the following sentence to section 6.3:

Any expenditure over \$200 shall be approved by a simple majority vote of the members present, in person or virtual, at a Members meeting prior to disbursement.

A second amendment is proposed to change the second sentence of section 6.3 to read:

The Treasurer Executive is authorized to spend up to \$200 on normal operations items without prior approval by the Membership.

This amendment makes this sentence consistent with the rest of this section, stating:

Any significant, non-routine payments, within this limit, must be agreed to, at minimum, by the President and the Treasurer plus 2 others of the Executive. This will be reported upon at the next Members' meeting.

Proposed amendments to were tabled at the September Meeting and were submitted to a vote.

Motion to approve the proposed amendments: Jason (VE3PRY) Seconded by Roger B. (VA3GBV) Adopted unanimously.

11- New business

- a. The nomination committee presented the slate proposed for the 2024-2025 executive
 - John Grow (VE2EQL) for President
 - Earnest Vinson (VA3EWV) for Vice-President
 - Secretary and Treasurer positions remain vacant for the present time,

The nomination committee also recommended Hunter (VA3HWF) as the Net Manager. It was suggested to put a new position – Evant Coordinator - in place. Jason (VE3PRY) volunteered to take on this roel should the new executive decide it to be necessary. The new executive will be decided on by an election at the November 2023 General Meeting.

b. Christmas Dinner: Earnest (VA3EWV) will be coordinating this event;

Location: Quinn's Inn Date December 5, 2023 Cocktails at 5:00, Dinner at 6:00 A signup sheet will be sent to the membership to get a preliminary head count to Quinn's by November 8, 2023. It is a family affair, bring family and friends.

c. SD&G Emergency training

The SVARC has been invited to participate in an emergency training and table top exercise on November 2 in Avonmore from 9:15 to 15:00.

Ed (VE3EAH) and Earle (VE3IMP) plan to attend.
