7- Technical Directors Report – Doug (VE3HTR):

The Club operates 8 repeaters and one APRS node.

The Echo-link and Allstar nodes are back on-line after replacing the defective Rasberry Pi card with a version 4 upgrade.

The VE3VSW repeater configuration was investigated and showed poorer performance than VE3PGC while operating at the same power level and sharing the same antennas. Results are still inconclusive.

Motion to approve Technical Director's report by Joe (VE3ADB) Seconded by Larry (VA3RSQ) Adopted unanimously.

The reduction in assets is partly due to the removal of the APRS node and several reconfiguration changes at the Cornwall Community Hospital (CCH).

> Motion to allow to disburse up to \$ \$1000: Roger (VA3GBV) Seconded: Joe (VE3ADB) Adopted.

Given that the membership extra fee for non-RAC members is \$10, while the premium the club has to pay to RAC for insurance coverage is \$13, it is being proposed to increase the club membership fee for non-RAC members from \$40 to \$45.

> Roger raised a motion to increase non-RAC membership fee: Roger (VA3GBV) Seconded: Joe (VE3ADB) Adopted.

It is proposed to amend the above motion to apply the increase fee to all members. Where the membership fee for 2024 will be as follows:

RAC Members: \$35 Non-RAC Members: \$45

9- Amateur of the year Award

A secret ballot was held to elect the Amateur Radio Operator of the year award, known as the Tim Smith Memorial Award.

The Award will be presented at the X-mas dinner on December 5, 2023.

10- Election of the executive:

The nominating committee had proposed the following nomination at the October 2023 meeting:

- a. **President:** John Grow (VE2EQL). There were no other candidates, John was elected by acclamation.
- b. Vice-President: Earnest (VA3EWV).
 From the floor, Marshall (VE3SX) proposed Hunter (VA3HWF) for Vice President, seconded by Jason (VE3PRY)
 A vote was held, and Hunter was elected Vice-President.
- c. **Treasurer:** No proposal from the nomination committee. Dean (VA3BS) proposed Chris (VA3CRR) for Treasurer, seconded by Roger (VA3GBV). There were no other candidates, Chris (VA3CRR) was elected by acclamation.
- d. **Secretary**: No proposal from the nomination committee. Joe (V3ADB) proposed Roger (VA3GBV) for Secretary, seconded by John (VE2EQL) There were no other candidates, Roger (VA3GBV) has been elected by acclamation.

11- New repeater equipment

It was recommended by Doug (VE3HTR) to take advantage of a promotion program by Yeasu and purchase a DR2-X Fusion (C4-FM) at a cost of \$750 USD. To make full use of the fusion capability of a DR2-X it was also recommended to purchase the optional LAN card for connectivity to the internet for a projected total cost of \$950 usd. Given the USD to Cdn exchange rate and shipping cost, it was recommended to approve an expenditure of up to \$1500 Cdn.

This repeater would be used to replace the VE3SDG UHF repeater. This repeater is presently a Kludge based on Motorola R-1225 transmitters and receivers.

The rationale for this recommendation is that presently the club owns only one or our 8 repeaters transmitters/receiver sub-systems.
