7- Technical Directors Report – Doug (VE3HTR):

9- ARES Report

Earle (VE3IMP) explained the purpose of the ARES (Amateur Radio Emergency Service) and in particular the SDG ARES group.

10- By-laws revision

Article 2.1 of the SVARC bylaws states:

Bylaw amendments require approval of 50% plus one of the full members in good standing, of the Club who are present at the meeting at which the amendments are voted on.

This is not in line with the "Robert's Rules of Order".

Robert's Rules of Order article 56:50 stipulates:

56:50 **Article IX: Amendment of Bylaws**. The bylaws should always prescribe the procedure for their amendment, and such provision should always require at least that advance notice be given in a specified manner, and that the amendment be approved by a two-thirds vote. If the bylaws contain no provision for their amendment, they can be amended by a two-thirds vote if previous notice (in the sense defined in 10:44) has been given, or they can be amended by the vote of a majority of the entire membership.

It is proposed to amend article 2.1 as follows:

Bylaw amendments require approval by a two-thirds vote of the members present or by a majority of the entire membership.

Notice of amendments shall be given at the club meeting preceding the meeting at which the amendments are voted on.

Notice is being given at the January 31, 2024, meeting and will be submitted to a vote at the February 28, 2024, meeting.
